CHECKLIST

For the *JCGG Instructions to Authors, Authorship & Conflicts of Interest Statement* form, and *Copyright Transfer Agreement* form, please visit the Journal's website at www.e-jcgg.com.

Only correctly prepared manuscript submissions will be considered for publication. Complete submissions must include:

- Cover letter
- Authorship & Conflicts of Interest Statement signed by all authors listed in the manuscript
- Copyright Transfer Agreement signed by all authors listed in the manuscript
- Manuscript in Microsoft Word format

AND, where applicable

- Review Committee letter of approval using human samples in research and human experiments
- Letter of approval from relevant authority for using animals in experiments
- CONSORT flow chart for randomized controlled trials
- Signed consent to publish (in print and online) from human subjects who may be identified in your manuscript
- Confirmation of copyright holder(s) permission(s) to use or adapt copyrighted sources in your manuscript

In the actual article, ensure that the following information is provided:

- Title page (double spaced)
 - Article category
 - Article title
 - Name(s), academic degree(s) and affiliation(s) of author(s)
 - Corresponding author details (name, e-mail, mailing address, telephone and fax numbers)
- Abstract (double spaced) required for: Review Articles (≤ 250 words), Original Articles (≤ 250 words), Brief Communications (≤ 150 words) and Case Reports (≤ 250 words)
 - Review Articles, Brief Communications and Case Reports: unstructured abstract (ie, a single paragraph with no section headings)
 - Original Articles: structured abstract, with the section headings Background/Purpose, Methods, Results, and Conclusion
- Keywords (double spaced) required for all article types except Editorials or Letters to the Editor
 - 3–5 keywords arranged alphabetically (ideally MeSH terms; see <http://www.ncbi.nlm.nih.gov/mesh?term>)
- Main text (double spaced)
- References (double spaced) in the correct format, cited in numerical order, and all listed references are cited in the Text/Tables/Figures and vice versa
 - Include family names and initials of all authors up to six. If seven or more, list the first six, followed by “et al”

AND, where applicable

- Conflicts of Interest Statement
- Funding/Support Statement
- Acknowledgments
- Table headings and tables (double spaced), each on a new page
- Figure legends (double spaced), on a new page
- Electronic picture files of all figures; resolution of 300 dpi for halftone images, 600 dpi for combination art (halftone + line art), and 1000 dpi for line art

Further considerations:

- Define all abbreviations at their first mention
- Ensure that data in the abstract matches those in the main text/tables/figures
- Spell-check and grammar-check your manuscript
